# Warburg-HIH Invest Acquires Premium Property Development in Cologne

- Acquisition earmarked for a property special AIF
- Mixed office-commercial building with annexed underground car park under construction in the highly coveted "City" office submarket
- Anchor tenant will be the international business consulting firm DLA Piper

Hamburg, 22 October 2015 – The Hamburg-based investment company Warburg-HIH Invest Real Estate GmbH (Warburg-HIH Invest, formerly: Warburg - Henderson) acquired the "Gürzenich-Quartier" mixed office-commercial building currently under construction in Cologne. The building of 13,000 square metres is earmarked for an institutional pool of segregated assets. The property is being raised on a plot of about 2,500 square metres across from the Gürzenich concert hall in downtown Cologne – a building constructed in the 15<sup>th</sup> century which today belongs to the most famous congress and events locations in Cologne. The asset is expected to be completed and ready for occupation by the second quarter of 2016. Seller and property developer is a joint venture between Metropol Immobilien und Beteiligungs GmbH and Johann Bunte Bauunternehmung GmbH & Co. KG.

The "Gürzenich-Quartier" is located at Augustinerstr. 10 / Martinstr. 3 in Cologne in direct extension of Schildergasse, Germany's most highly frequented pedestrian precinct, and just 350 metres from the bank of the Rhine. The planned eight-storey building cluster will have a gross lettable area or 13,000 square metres. About 1,700 square metres on the ground floor are intended for retail units, whereas the upper floors comprehend high-class office and practice space on more than 11,300 square metres. The building also provides 65 parking spots in its underground car park. Main
